#### Family Bereavement Leave Act

The Family Bereavement Leave Act provides up to two weeks of unpaid leave for certain family emergencies. These include the death of a close family member, stillbirth, miscarriage, unsuccessful reproductive procedure, failed adoption match, failed surrogacy agreement, or a diagnosis that negatively impacts pregnancy or fertility. Employees are entitled to a maximum of six weeks of leave if they experience more than one event during a 12-month period.

Employees may use FBLA leave time to grieve; attend the funeral or alternative to a funeral of a covered family member; or make arrangements necessitated by the death of the covered family member.

FBLA leave time must be completed within 60 days after the date the employee receives notice of the event. Employees must give their employer at least 48 hours' notice before taking FBLA leave, unless not reasonable or practicable.

# Victims' Economic Security and Safety Act (VESSA)

Public Act 103-0314 amends the Victims' Economic Security and Safety Act (VESSA). The amendment to VESSA allows employees to take up to two weeks of unpaid, job-protected leave from work to attend a funeral, arrange a funeral, or grieve, if a family or household member is killed in a crime of violence.

Existing VESSA provisions allow unpaid time off for reasons including, but not limited to, medical attention, counseling, victim services, relocating, or participating in legal proceedings. VESSA applies to employers of all sizes.
